Weedon Village Hall GDPR Privacy Policy

How Weedon Village Hall Management Committee (WVHMC) respect privacy when we deal with personal information collected through organisation

This Privacy Policy applies to information WVHMC collect about individuals who interact with our organisation. It explains what personal information we collect and how we use it.

1. Personal data that we process

The following table explains the types of data we collect and the legal basis, under current data protection legislation, on which this data is processed.

Purpose	Data (key elements)	Basis
Enquiring about hiring the Hall or Annex	Name, email, message	Legitimate interests - it is necessary for us to read and store your message so that we can respond in the way that you would expect.
Hirers of Hall	Name, email address and contact	Contract purposes , Agreement of Terms and conditions applicable. Insurance purposes
Making a donation (WVHMC is a registered Charity No 304445)	Name, email, address, payment information	Legitimate interests - this information is necessary for us to fulfil your intention of donating money and your expectation of receiving a confirmation message.
Becoming a Trustee or Committee member	Name, email, Address Phone number. DoB	Legal Requirement. Information needs also to be lodged with the Charity Commission for Trustees
Volunteer Helper	Name and Contact	Legitimate interests - it is necessary for us to store a small amount of information for contact purposes and for Insurance purposes
Employee	Name and Contact	Contract purposes and legal requirements

2. How we use your data

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy. Contd.

For example, we may use your personal information to:

- reply to enquiries you send to us;
- handle donations or other transactions that you initiate;
- where you have specifically agreed to this, send you marketing communications by email relating to our work which we think may be of interest to you.

3. When we share your data

We will only pass your data to third parties in the following circumstances:

- you have provided your explicit consent for us to pass data to a named third party;
- we are using a third party purely for the purposes of processing data on our behalf and we have in place a data processing agreement with that third party that fulfils our legal obligations in relation to the use of third-party data processors
- we are required by law to share your data.
- Lifesaving circumstances

In addition, we will only pass data to third parties outside of the EU where appropriate safeguards are in place as defined by Article 46 of the General Data Protection Regulation.

4. How long we keep your data

We take the principles of data minimisation and removal seriously and have policies in place to ensure that we only ever ask for the minimum amount of data for the associated purpose and delete that data promptly once it is no longer required.

5. Rights you have over your data

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time and we will make it as easy as possible for you to do this
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Information Commissioner if you feel your rights have been infringed.
